ORDER RECOGNIZING CHANGE OF CORPORATE NAME AND APPROVING TARIFFS

On December 10, 1993, International Telecharge, Inc. (Company) submitted a request to the Public Service Commission (Commission) for recognition of its change of corporate name from "International Telecharge, Inc." to "Operator Communications, Inc." International Telecharge, Inc. has operated in the past under the fictitious name of "Oncor Communications, Inc." as recognized by the Commission in Case No. TA-94-37; Operator Communications, Inc. will continue to use that fictitious name. Company's initial tariffs were approved by the Commission on August 1, 1990, in Case No. TR-90-327; the tariff, revised to show the fictitious name, was approved in Case No. TO-94-37. Company filed revised tariff sheets on December 23, 1993, reflecting the new corporate name and bearing an effective date of January 22, 1994. Other than the change of name, no changes appear in the text or rates of these tariff sheets.

On January 12, 1994, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum giving its recommendation. Staff stated that it had reviewed Company's filing and the tariff sheets filed on December 23, 1993, and had no objection to Company's change of name. Staff recommended that the Commission approve the tariffs. Staff was of the opinion that no customer notice of the revised tariffs was necessary since customers will continue to

receive service from the corporation under its fictitious name of "Oncor communications, Inc." and the tariffs make no change in service or rates.

Having reviewed Company's filing, the tariff sheets, and Staff's recommendation, the Commission finds that Company's change of name should be recognized. The Commission further finds that the tariff sheets reflecting that change of name are reasonable and will cause no inconvenience to ratepayers. The Commission finds that the proposed tariffs filed on December 23, 1993, are identical in the services and pricing they describe to the tariffs approved for Company in prior rate cases and that these revised tariffs should be approved. The Commission notes that, although the tariff sheets are denominated "original", they have been revised to the extent that they change the corporate name.

IT IS THEREFORE ORDERED:

- 1. That the change of corporate name from "International Telecharge,
 Inc." to "Operator Communications, Inc." is hereby recognized.
- 2. That the tariffs filed by Operator Communications, Inc. on December 23, 1993, are hereby approved for service on and after January 22, 1994. The tariff sheets approved are:
