**ORDER CANCELING CERTIFICATE**

Effective Date: December 24, 2005

On December 2, 2005, the Staff of the Commission filed a motion asking the Commission to cancel the certificates of service authority to provide private payphone service that were issued to Nurwahyu Fajaryanto in Case Number TA-2002-0272, and to Nurwahyu Fajaryanto, d/b/a NF Enterprises, in Case Number TA-2002-0288. Staff's motion states that mail sent to the address provided by the certificate holders has been returned as undeliverable. Attempts to contact the certificate holders by telephone have been unsuccessful. Staff states that Nurwahyu Fajaryanto indicated on the Fiscal Year 2006 Statement of Revenue filed with the Commission that he does not wish to retain an operating certificate. Nurwahyu Fajaryanto, d/b/a NF Enterprises, has not filed a statement of revenue.

Neither Nurwahyu Fajaryanto, nor Nurwahyu Fajaryanto, d/b/a NF Enterprises, has responded to Staff's motion.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo (Supp. 2004), which states, in part: "Any certificate of service

authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, and on the certificate holder’s failure to respond, the Commission finds that the certificates of service authority granted to Nurwahyu Fajaryanto, and Nurwahyu Fajaryanto, d/b/a NF Enterprises, should be canceled.

**IT IS THEREFORE ORDERED:**

1. That the certificate of authority to provide private payphone services granted to Nurwahyu Fajaryanto, in Case Number TA-2002-0272, is canceled.
2. That the certificate of authority to provide private payphone services granted to Nurwahyu Fajaryanto, in Case Number TA-2002-0288, is canceled.
3. That this order shall become effective on December 24, 2005.
4. That this case may be closed on December 25, 2005.
