ORDER CANCELING CERTIFICATE

Issue Date: June 9, 2017

Effective Date: June 19, 2017

This order cancels the private pay telephone certificate of Commercial Pay Phones, Inc.

On May 22, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Commercial Pay Phones' certificate to provide private pay telephone service in the State of Missouri be canceled.

In Case Number TA-97-159, the Commission granted Commercial Pay Phones a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that the company is deficient in filing its Statement of Revenue for years 2012 through 2016 and has also failed to submit its assessment payment for fiscal year 2015. The phone number listed in Commercial Pay Phones' contact information in EFIS is not current. Staff recommends that the Commission cancel Commercial Pay Phones' certificate of service authority as the company is no longer providing service in Missouri.

On May 23, 2017, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than June 6, 2017. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo 2016 which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the private payphone certificate granted to Commercial Pay Phones, Inc., shall be canceled.

THE COMMISSION ORDERS THAT:

1. The private payphone certificate granted to Commercial Pay Phones, Inc., in Case Number TA-97-159, is canceled.
2. This order shall become effective on June 19, 2017.
3. This case may be closed on June 20, 2017.
