APPLICATION FOR FURTHER EXTENSION OF TIME

COMES NOW Peaceful Valley Service Company (hereinafter "Applicant" or "Company"), pursuant to 4 CSR 240-3.335(7) and 4 CSR 240-3.640(7), Section 393.140, RSMo 2000 and 4 CSR 240-2.060(4), and for its application states the following to the Missouri Public Service Commission ("Commission"):

1. Applicant is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principal office and place of business located at 3408 B Peaceful Valley Road, Owensville, MO 65066. Pursuant to 4 CSR 240-2.060(1)(B), Applicant's certificate of good standing from the Missouri Secretary of State's office is attached as **Appendix 1**.

2. Applicant currently provides water and sewer services to members of the public located in Gasconade County, Missouri and, accordingly, is subject to the jurisdiction, control and regulation of the Commission as provided by law.

4. On April 13, 2011, Applicant requested and was granted a 30-day extension of time to file its annual report for its regulated water and sewer operations that was due to be filed on April 15, 2011. See Tracking Nos. BARE-2011-1216 and BARE-2011-1218.

5. Applicant hereby requests an additional extension of time, up to and including July 15, 2011 within which to file its annual report. Applicant's former accountant has left Applicant's longtime accounting firm, and the new accountant is unfamiliar with Public Service Commission annual reports. Therefore, the process is taking longer than anticipated.

6. This request is not for purposes of delay. If granted it will not prejudice any party but will allow the Company to accurately prepare its annual report.

7. Applicant has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates in which action, judgment or decision has occurred within three (3) years of the date of this application.

8. Applicant has no annual report or assessment fees which are currently overdue.

WHEREFORE, Peaceful Valley Service Company respectfully requests that the Commission extend the time within which it may file its annual report to July 15, 2011.
