The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on PayCom Voice Enterprises, LLC's request and Staff's recommendation, the Commission finds that the certificate of service authority granted the company, shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide pay telecommunications services granted to PayCom Voice Enterprises, LLC in File Number PA-2013-0475, is canceled.
3. This order shall become effective on June 29, 2018.
4. This case may be closed on July 2, 2018.
