- 4. Cooperative has no information or belief upon the subject sufficient to enable Cooperative to answer the allegations of Paragraph 4 of the complaint and therefore denies those allegations.

5. Given Ameren UE's statement in Paragraph 7 of its Answer, that Ameren UE does not object to Complainant's request to change electric providers, Cooperative will agree to provide electric service to Petitioner's home if the Commission grants Petitioner's request. Cooperative's written consent to supply electric service to Petitioner and estimated cost of providing service are attached and adopted by reference.

Dear Commission:

In response to Order dated December 21, 2004, <u>Therron Nowlin vs. AmerenUE</u> we submit the following:

Pemiscot-Dunklin Electric Cooperative was surprised, yet somewhat apprehensive of Mr. Nowlin's request to become a member. Our first thought was, this could cause unwanted hard relationships between the two electric power suppliers who at the present time have a good working relationship.

Pemiscot-Dunklin Electric Cooperative Rural Line Extensions-Permanent Facility, Single Phase Service, Policy No. 10-5, which is attached, under "G" states that the first 500 feet of overhead line construction will be at no cost to the member. The estimated cost to construct the overhead line would be \$2,923.57, provided Mr. Nowlin could connect to an existing line at no cost that a member had previously paid to have constructed.

Mr. Nowlin had indicated he would prefer the line, after crossing the county road, to be underground. The estimated cost of partial overhead and underground would be \$3,572.49. Mr. Nowlin would be required to pay for all of the underground portion and we estimate Mr. Nowlin's cost would be \$2,181.71, under Policy No. 10-5 (F2), and the Coop's cost to be \$1,390.78.

Mr. Nowlin would also be required to place a \$100.00 deposit, \$20.00 connect fee and the cost of metering, which we estimate to be \$180.00.

Pemiscot-Dunklin Electric Cooperative strives to provide a reliable source of electrical power and service to all the members and will abide by the decision of the Commission.

Pemiscot-Dunklin Electric Cooperative will accept Therron Nowlin as a member.
