Comes now Cass County Telephone Company, L.P. ("CassTel") and for its Request for Extension of Time to File Annual Report pursuant to 4 CSR 240-3.540(7) states to the Missouri Public Service Commission ("Commission") as follows:

- 1. CassTel is a Maryland limited partnership, and it currently provides basic local telecommunications service to approximately 7,900 access lines in Missouri. Its principal office is located at 260 West First Street, Peculiar, MO 64078. Its mailing address is P.O. Box 398, Peculiar, MO 64078, and its telephone and fax numbers are (816) 779-5333 and (816) 779-5551 respectively. CassTel is authorized to do business in Missouri, and its Certificate of Good Standing was filed with the Commission in Case No. TC-2002-1077 and is hereby incorporated by reference. A copy of CassTel's limited partnership agreement was filed with the Commission in Case No. TM-2006-0306.

- 3. On April 12, 2006, CassTel informed the Commission by letter that it would require an additional thirty (30) days to submit its Annual Report to the Commission. CassTel now finds that it will require additional time up to May 22, 2006, to complete and file its Annual Report with the Commission. The employees of CassTel, as well as its outside auditors, have been involved in preparing the company for sale as well as other regulatory matters before the Commission, the Kansas Corporation Commission ("KCC") and the Federal Communications Commission ("FCC").
- 4. CassTel currently has a pending Commission complaint in Case No. TC-2005-0357 that is the subject of a settlement Stipulation and Agreement between CassTel and the Staff of the Commission, an earnings investigation by the Commission in Case No. IR-2006-0374 and an order was recently issued by the KCC in its investigation, Case No. 05-GIMT-094-GIT. CassTel also has pending an application for the sale and transfer of its assets in Case No. TM-2006-0306.
- 5. Other than the annual report that is the subject of this request, CassTel does not have any annual reports or assessment fees that are overdue.
- 6. CassTel certifies that a copy of this request has been sent to all parties of record in cases where its activities are the primary focus of the proceeding.

Wherefore, CassTel respectfully requests that the Commission grant its Request for Extension of Time to File its Annual Report up to May 22, 2006, and for any other relief appropriate in the circumstances.
