ORDER CANCELING PRIVATE PAY TELEPHONE CERTIFICATES

Issue Date: October 17, 2005 Effective Date: October 27, 2005

This order cancels the private pay telephone certificates of TSC Payphone Corp., Universal Communications, Inc., Cherokee Communications, Inc., Cherry Communications, Inc., and CAD, Inc., (hereinafter collectively referred to as "Providers").

On July 20, 2005, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificates to provide pay telephone service of the Providers be canceled. Staff alleges that it is unable to contact the Providers through either a mailing address or a telephone number. Staff also states that each of the 2006 statement of revenue forms mailed to the Providers on January 14, 2005, was returned as undeliverable. Staff also states that each of the Providers is a corporation which was administratively dissolved by the Missouri Secretary of State.

Furthermore, Staff argues that by failing to keep the Commission informed of a current address, the Providers have each denied the Commission the ability to supervise

their telecommunications operations and services¹ and have denied the Commission access to their books and records.² Staff served its motion on the registered agent for service of process of each of the Providers. No responses were filed.

Section 392.410, RSMo 2000, gives the Commission authority over the granting of certificates of service authority to provide telecommunications services. The Commission has reviewed the motion and finds that the private payphone certificates granted to each of the Providers shall be canceled.

To ensure that the Providers have had every opportunity to respond, the Commission shall order its Data Center to serve a copy of this order on the company address and the registered agent address as listed in Staff's motion.

IT IS THEREFORE ORDERED:

- That the private payphone certificate granted to TSC Payphone Corp., in Case No. TA-98-262 is canceled.
- 2. That the private payphone certificate granted to Universal Communications, Inc., in Case No. TA-95-5 is canceled.
- 3. That the private payphone certificate granted to Cherokee Communications, Inc., in Case No. TA-93-339 is canceled.
- 4. That the private payphone certificate granted to Cherry Communications, Inc., in Case No. TA-92-265 is canceled.
- 5. That the private payphone certificate granted to CAD, Inc., in Case No. TA-98-304 is canceled.
