ORDER CANCELING PRIVATE PAY
TELEPHONE CERTIFICATES

Issue Date: July 9, 2007

Effective Date: July 19, 2007

This order cancels the private pay telephone certificates of Loretta A. Lock d/b/a Branson Stagecoach RV Park, Earl D. Thomas, Patricia L. Stone d/b/a Future Talk, Glen J. Roderick, Howard and Barbara Messerli d/b/a Jenkins Kwik Stop, Vivek Dayal d/b/a Phone Tech Communications, Ted E. Beliel and Tammy Holcomb, Debbie A. Cox, Thomas A. Schrage, and Carl Kent (hereinafter collectively referred to as "Providers").

On May 24, 2007, the Staff of the Missouri Public Service Commission filed a motion requesting that the Providers' certificates to provide private pay

telephone service be canceled. Staff alleged that each of the Providers have no past due assessments, indicate in their FY 2008 (pertaining to calendar year 2006) statement of revenue forms that they do not wish to retain their operating certificate, and no formal complaints have been filed against any Providers since the commencement of the Electronic Filing and Information System.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion and the Providers’ requests to cancel the certificates included in their statements of revenue, the Commission finds that the private payphone certificates granted to each of the Providers shall be canceled.

IT IS ORDERED THAT:

1. The private payphone certificate granted to Loretta A. Lock d/b/a Branson Stagecoach RV Park, in Case Number TA-2001-598, is canceled.
2. The private payphone certificate granted to Earl D. Thomas, in Case Number TA-96-258, is canceled.
3. The private payphone certificate granted to Patricia L. Stone d/b/a Future Talk, in Case Number TA-2000-327, is canceled.
4. The private payphone certificate granted to Glen J. Roderick, in Case Number TA-99-479, is canceled.
5. The private payphone certificate granted to Howard and Barbara Messerli d/b/a Jenkins Kwik Stop, in Case Number TA-98-585, is canceled.

6. The private payphone certificate granted to Vivek Dayal d/b/a Phone Tech Communications, in Case Number TA-91-67, is canceled.

7. The private payphone certificate granted to Ted E. Beliel and Tammy Holcomb, in Case Number PA-2005-0502, is canceled.

8. The private payphone certificate granted to Debbie A. Cox, in Case Number TA-2001-49, is canceled.

9. The private payphone certificate granted to Thomas A. Schrage, in Case Number TA-99-229, is canceled.

10. The private payphone certificate granted to Carl Kent, in Case Number PA-2004-0573, is canceled.

11. This order shall become effective on July 19, 2007.

12. This case may be closed on July 20, 2007.
