## ORDER CANCELING PAYPHONE REGISTRATION

Issue Date: August 25, 2021

Effective Date: September 24, 2021

On August 12, 2021, the Commission's Staff filed a motion asking the Commission to cancel the payphone registration of HKH Management Services, Inc. (HKH). The Commission granted HKH that registration in File No. PA-2005-0036, on August 23, 2004.

Staff explains that HKH notified the Commission in its 2021 Statement of Revenue that it does not serve any customers in Missouri and requests its registration be canceled. Staff indicates HKH's request to cancel its registration is in compliance with Commission rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that registration.

On August 12, 2021, the Commission issued an order allowing parties until August 23, 2021, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on the company's request, and Staff's motion, the Commission finds that the registration granted to HKH shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The registration to provide payphone services granted to HKH in File Number PA-2005-0036, is canceled.
2. This order shall become effective on September 24, 2021.
3. This file may be closed on September 25, 2021.
