REQUEST OF APPLICANTS FOR AN EXTENSION OF TIME TO PROVIDE INFORMATION PURSUANT TO ORDER DIRECTING FILING

Claricom Networks, Inc., Claricom Holdings, Inc., Staples, Inc., Stacom Holdings, LLC, and Platinum Equity, LLC ("Applicants") request a short extension of time to comply with the Commission's June 18, 2001 Order Directing Filing. In support of this request, Applicants state as follows:

1. Applicants filed a Joint Application for Approval of the Transfer of Stock in Claricom Holdings, Inc. to Stacom Holdings, Inc. on June 7, 2001.

2. On June 18, 2001, the Commission issued an Order Directing Filing (the "Order"). The Order required the filing of additional information by June 28, 2001. Specifically, the Commission ordered Claricom to file a supplemental pleading which must include: (1) a statement indicating whether Claricom has any pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment, or decision has occurred within three years of the date of the application; and (2) a statement that Claricom has no annual report or assessment fees that are overdue.

3. Counsel for Applicants and Applicants have been diligently seeking the required information. Despite diligent efforts, the information has not yet been obtained. Counsel for Applicants believes the information will be obtained shortly.
