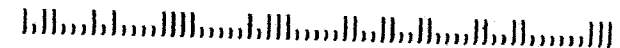

ORDER CANCELING CERTIFICATE

Issue Date: January 25, 2012

Effective Date: February 4, 2012

On December 28, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Wesley Robinson's certificate of service authority to provide private pay telephone services in the State of Missouri be cancelled.

In File Number TA-94-326, the Commission granted Mr. Robinson a certificate of service authority to provide private pay telephone service in the State of Missouri.

Staff states in its motion that Mr. Robinson has not filed statements of revenue for the years 2007 through 2011. Because Mr. Robinson failed to abide by the Commission's statutes, Staff recommends that the Commission cancel Mr. Robinson's certificate of service authority to provide private pay telephone service.

On December 29, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than January 10, 2012. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority

may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion the Commission finds that the certificate of service authority granted to Wesley Robinson, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide private pay telephone services granted to Wesley Robinson, in File Number TA-94-326, is canceled.
2. This order shall become effective on February 4, 2012.
3. This case may be closed on February 5, 2012.


