On May 5, 2018, PayCom Voice Enterprises, L.L.C. (“PayCom”) filed a letter surrendering its certificate of service authority.

In Case Number PA-2013-0475, the Commission granted PayCom a certificate to provide private pay telecommunications services.

The Commission will direct its Staff to review the request and file a recommendation regarding the surrender of PayCom's certificate of service authority.

IT IS ORDERED THAT:

1. No later than May 21, 2018, the Staff of the Missouri Public Service Commission shall file a recommendation regarding PayCom Voice Enterprises, L.L.C.'s request to surrender its certificate of service authority.
