On March 26, 2014, Grain Belt filed an application with the Commission for a Certificate of Convenience and Necessity to construct, own, operate, control, manage and maintain a high voltage, direct current transmission line and associated facilities within Buchanan, Clinton, Caldwell, Carroll, Chariton, Randolph, Monroe and Ralls Counties, Missouri, as well as an associated converter station in Ralls County.

- 4. Energy for Generations has an interest in this proceeding because Petitioner is a potential customer of the transmission line capacity and the other services for which Grain Belt seeks authority by this application to provide. Additionally, issues related to renewable energy sources, like power derived from wind, and commerce involving renewable energy sources are important to the public and to the electric power industry in Missouri and nationwide. In its brief, Energy for Generations can provide a broader industry perspective on such issues. Energy for Generations asserts that the matters addressed in its brief will assist the Commission in reaching a well-informed decision on the issues anticipated in this case.
