**REQUEST FOR WAIVER AND
MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE or Company) and
for its *Request for Waiver and Motion for Expedited Treatment*, states as follows:

1. On March 15, 2007, the Missouri Public Service Commission (Commission) issued an order approving the Stipulation and Agreement (Stipulation) filed in Case No. GR-2007-0003. Paragraph 6 of the Stipulation requires AmerenUE to provide certain information concurrently with its annual ACA filing. This provision of the Stipulation has been embodied in AmerenUE's tariff in Rider A, Section III, paragraph 10 on Sheet No. 29.1.
2. AmerenUE's next ACA filing is due to be filed no later than October 18, 2007.
3. Due to the press of other business, AmerenUE will not be able to provide the information required by the Stipulation and its tariff at the time of filing.
4. The Company asks that the Commission waive the requirement that the information be provided at the time of filing. The request for a waiver applies only to the upcoming October 18, 2007, filing. Instead, AmerenUE will provide this information to the Commission Staff (Staff) no later than December 1, 2007.
5. The Company has discussed this matter with Staff and Staff does not object to this request.

6. AmerenUE asks the Commission to approve this request no later than October 17, 2007. Approval of this request on an expedited basis is necessary so that AmerenUE can make the filing on October 18, 2007. This pleading was filed as soon as it could have been after discussing the situation with Staff to ensure there was no objection to this request.

WHEREFORE, for the reasons stated herein, AmerenUE respectfully requests that the Commission approve this waiver request no later than October 17, 2007.
