# AMENDMENT TO APPLICATION FOR CERTIFICATE OF SERVICE AUTHORITY TO PROVIDE INTEREXCHANGE TELECOMMUNICATIONS SERVICE AND FOR COMPETITIVE CLASSIFICATION

COMES NOW Residential Long Distance, Inc. ("Residential Long Distance" or "Applicant"), and, pursuant to 4 CSR 240-2.080(20), files this Amendment to its Application for Certificate of Service Authority to Provide Interexchange Telecommunications Service and For Competitive Classification ("Application"). In support of this Amendment, Applicant states:

- 1. On June 2, 2011 Residential Long Distance filed its Application with the Commission, Case No. TO-2011-0386, requesting that the Commission grant Applicant a Certificate of Service Authority to provide interexchange telecommunications services pursuant to Section 392.410; grant competitive status to Applicant, and classify the Applicant's services as competitive, pursuant to Section 392.461; waive certain Commission rules and statutory provisions, pursuant to Section 392.420; and approve Applicant's initial tariff.
- 2. In Paragraph 8 of its Application, Applicant requested waiver of a number of statutes and regulations for Applicant and its interexchange services offerings.
- 3. Applicant attached its proposed interexchange tariff, Original Sheet 2 of which is titled "Waiver of Rules and Regulations," to its Application as Exhibit C.
- 4. Staff has requested that Applicant amend its Application and tariff to include the following list of waivers:
