**AS HIGHLY CONFIDENTIAL**


COMES NOW XO Missouri, Inc. and hereby requests that the Commission treat certain portions of its Annual CLEC Report for 2001, submitted herewith, as Highly Confidential.

Pursuant to Rule 4 CSR 240-10.080(7), XO Missouri, Inc. requests that the access line counts in its CLEC annual report be treated as highly confidential. As grounds for requesting highly confidential treatment of this portion of the annual report XO Missouri, Inc. states that this portion of the annual report contains company specific, state-specific information that is not otherwise publicly available. The information contained in this report could be used by competitors to determine the extent of XO Missouri, Inc.'s business operations in Missouri, including the extent of network facilities, and other items that are of a competitively sensitive nature. Disclosure of this type of information to competitors would be detrimental to XO Missouri, Inc.'s business interests in Missouri. The competitively sensitive information contained in this report is not otherwise in the public domain. The Commission has previously protected this type of information.

The report is submitted herewith, together with the documents referred to therein, in a non-proprietary format, and a highly confidential version filed under seal.

WHEREFORE, XO Missouri, Inc. requests that for the foregoing reasons, the Commission issue an order allowing highly confidential treatment of the identified provisions of its 2001 CLEC Annual Report.


