- 1. On November 28, 2006, Mike Bennett of 704 State Highway P, New Madrid, Missouri 63869 ("Bennett") initiated this proceeding by filing an Application for Change of Electric Service Provider ("Application"). Bennett requested that his electric service be provided by SEMO Electric Cooperative ("SEMO") rather by AmerenUE.
- 2. On November 29, 2006, the Missouri Public Service Commission ("Commission") issued an order directing AmerenUE to respond to the Application.
- 3. AmerenUE does not object to this transfer and, in fact, believes that it is in the public interest for reasons other than rate differential. COMES NOW, Union Electric Company d/b/a AmerenUE ("Company"), a Missouri corporation, in response to an Order and Notice and Order Directing Filing dated November 29, 2006 of the Missouri Public Service Commission ("Commission"), states as follows:

- 1. Company is a corporation organized and existing under the laws of the State of Missouri, in good standing in all respects, with its principal office and place of business located at One Ameren Plaza, 1901 Chouteau Avenue, St. Louis, Missouri 63103. Company is an electrical corporation subject to the jurisdiction of the Commission and engaged in the sale and distribution of electricity in portions of Missouri, including the area in and around 704 State Highway P in New Madrid, Missouri 63869.

- 3. This case involves an application by Mr. Mike Bennett ("Bennett") for Commission approval of a change of its electric service provider from Company to SEMO Electric Cooperative ("SEMO").
- 4. In support of his Application, Bennett states that he has experienced numerous outages. Application of Bennett at ¶5. Company admits that this assertion is correct.
- 5. Bennett further states that he has had multiple discussions with AmerenUE in an attempt to prevent outage problems from the long single phase tap through which he is served. Application of Bennett at ¶6. Company admits this assertion is correct.
- 6. Bennett's property is located at the end of a mile-long feeder which does not serve any other AmerenUE customer. The physical location of the property is such that SEMO would be able to provide a more direct tie into a service line than Bennett currently has to AmerenUE and this should result in fewer outages for the Bennett household.
- 7. The Company recommends the Commission approve this requested change in electric supplier as being in the public interest for reasons other than rate differential. Notwithstanding the foregoing, Company request that in its Order (i) require the Company to cut open the facilities serving Bennett's residence, (ii) require SEMO to return to Company any and all transformers associated with Bennett's existing service, and (iii) require SEMO take title to all existing facilities serving Bennett's residence after said facilities are cut open by Company. These steps are necessary to permit SEMO to obtain maximum use of the existing facilities and to limit Company's ongoing liability.
