AN ORDINANCE TRANSFERRING THE ASSET OF EASTERN MISSOURI UTILITIES CO., INC. TO THE CITY OF FORISTELL.

WHEREAS, the Board of Aldermen of the City of Foristell have previously purchased the total outstanding shares of Eastern Missouri Utilities Co., Inc.;

WHEREAS, The City of Foristell now owns all three hundred (300) issued shares of Eastern Missouri Utilities Co., Inc. and no other entity or person owns shares in Eastern Missouri Utilities Co., Inc.;

WHEREAS, The Board of Aldermen desire to transfer all of Eastern Missouri Utilities Co., Inc.'s assets to the City of Foristell;

WHEREAS, The Board of Aldermen of the City of Foristell desire to dissolve Eastern Missouri Utilities Co., Inc. after all assets have been transferred to the City of Foristell.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF FORISTELL, MISSOURI AS FOLLOWS:

- Section 1. Eastern Missouri Utilities Co., Inc. shall transfer all of its assets to be titled in the name of the City of Foristell, Missouri.
