SNGMO'S NOTICE OF INTENDED CASE FILING

COMES NOW Summit Natural Gas of Missouri, Inc. (“SNGMo” or “Company”), pursuant to Commission Rule 20 CSR 4240-4.017, files this *Notice of Intended Case Filing* and respectfully states as follows to the Missouri Public Service Commission ("Commission"):

1. The Company is a wholly-owned subsidiary of Summit LDC Holdings, LLC, which is a wholly-owned subsidiary of Summit Utilities, Inc. The Company is a corporation duly incorporated under the laws of the State of Colorado, with its principal offices located at 10825 E. Geddes Avenue, Suite 410, Centennial, CO 80112.

2. The Company conducts business as a “gas corporation” and a “public utility” as those terms are defined at §386.020, RSMo, and provides natural gas service in the Missouri counties of Benton, Caldwell, Camden, Daviess, Douglas, Greene, Harrison, Howell, Laclede, Miller, Morgan, Pettis, Stone, Taney, Texas, Webster, and Wright, subject to the jurisdiction of the Commission as provided by law.


3. Commission Rule 20 CSR 4240-4.017(1) provides, in part, as follows:

Any person that intends to file a case shall file a notice with the secretary of the commission a minimum of sixty (60) days prior to filing such case. Such notice shall detail the type of case and issues likely to be before the commission and shall include a summary of all communication regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to filing the notice.

4. It is SNGMo's intent to file tariffs to initiate a general rate case proceeding seeking an increase in its natural gas rates. Issues likely to be before the Commission in the upcoming rate case include those concerning revenue requirement, rate design, tariff, and other matters commonly associated with a general rate case. SNGMo has had no communications with the Office of the Commission (as defined in 20 CSR 4240-4.015(10)) respecting this filing during the 90 days prior to filing this notice.

WHEREFORE, SNGMo submits to the Commission and its Secretary this *Notice of Intended Case Filing*.
