**DISMISSAL OF APPLICATION FOR ADOPTION OF INTERCONNECTION
AGREEMENT**

Comes now Comcast Phone of Missouri, LLC, dba Comcast Digital Phone (“Comcast-MO”), by its undersigned attorneys, and pursuant to 4 CSR 240-2.116(1), dismisses its Application for Adoption of Interconnection Agreement. In support of this Dismissal, Comcast-MO states the following:

1. Comcast-MO initiated this proceeding with the filing of its Application on August 24, 2005. Since that date, Comcast-MO and SBC Missouri have entered into the adoption of an interconnection agreement. Comcast-MO filed a letter and copy of the adoption agreement on September 14, 2005 with the Commission. Pursuant to 4 CSR 240-3.513(4)(A), the adoption was effective upon filing.

2. In that the parties have recently entered into an interconnection agreement, the captioned proceeding is no longer necessary and Comcast-MO hereby dismisses its Application. Under 4 CSR 240-2.116(1), as the applicant in the matter, Comcast-MO may dismiss the case without seeking Commission approval before the filing of prepared testimony. No testimony has been filed in this case.

Wherefore, Comcast-MO hereby dismisses this case.
