**AMEREN MISSOURI'S REQUEST
TO OPEN CASE AND FOR AUTOMATIC INTERVENTION
OF PARTIES TO PREVIOUS CASE**

COMES NOW, Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri or the Company), and for its *Request to Open Case and for Automatic Intervention of Parties to Previous Case*, states as follows:

1. Ameren Missouri will be filing its Integrated Resource Plan later today.
2. Previously, Ameren Missouri obtained waivers in Case No. EE-2010-0243. In that case, several parties requested and were granted intervention. Additionally, several parties filed either Non-Disclosure Agreements or Certificates of Compliance, so that their consultants were able to review Highly Confidential information.
3. In order to expedite Ameren Missouri's ability to provide Highly Confidential information in this new case, the Company requests the Commission issue an order which makes parties to Case No. EE-2010-0243 a party to the new case without the need for those parties to file an application to intervene. Additionally, the Company requests the Commission order all Non-Disclosure Agreements and Certificates of Compliance filed in Case NO. EE-2010-0243 be treated as if they were also filed in this new case.
4. Upon issuance of this order, Ameren Missouri will be able to provide all parties with the Highly Confidential portion of the filing as well as the Highly

Confidential workpapers without delay and retain the protection of the Commission's rules on Highly Confidential information.

WHEREFORE, Ameren Missouri requests the Missouri Public Service Commission open a case and order that parties to Case NO. EE-2010-0243 be made a party to the new case and order that all Non-Disclosure Agreements and Certificates of Compliance be treated as if they were filed in the new case.
