## ORDER SETTING LOCAL PUBLIC HEARING

On December 13, 2007, Kenneth Jaeger and Blue Lagoon, LLC, filed a joint application. That application requests, among other things, authority from the Commission for Mr. Jaeger to transfer his Ralls County, Missouri, Iagoon and sewer system to Blue Lagoon, LLC, to grant Blue Lagoon, LLC, a certificate of convenience and necessity, and to allow Blue Lagoon, LLC, to charge certain rates to its customers.

3. The local public hearing will be held in facilities that meet the accessibility

5. The applicants shall mail notice of this hearing to each customer of the sewer

system, with notice mailed no later than March 16, 2008, and shall file a verified pleading in
