ORDER GRANTING MOTION TO INTERVENE AND SETTING PREHEARING CONFERENCE

On December 13, 2007, Kenneth Jaeger and Blue Lagoon, LLC, filed a joint application. That application requests, among other things, authority from the Commission for Mr. Jaeger to transfer his Ralls County, Missouri, Iagoon and sewer system to Blue Lagoon, LLC, to grant Blue Lagoon, LLC, a certificate of convenience and necessity, and to allow Blue Lagoon, LLC, to charge certain rates to its customers.

On January 3, 2008, Salt River Resort, LLC, filed a Motion to Intervene. Salt River Resort pleads that has an interest in this case different from that of the general public due to its property being one of the limited numbers of properties to be served by the lagoon and sewer system which is the subject of this application.

Commission Rule 4 CSR 240-2.080(15) allows parties ten days to respond to motions. No party responded within ten days. Therefore, the Commission will take up the application unopposed.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be

adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. Upon review of the unopposed application, the Commission finds that Salt River Resort meets the standards in Commission Rule 4 CSR 240-2.075(4). Therefore, the Commission will grant the motion to intervene.

Also, the Commission finds it appropriate to set a prehearing conference in this matter.

IT IS ORDERED THAT:

- 1. The Motion to Intervene filed by Salt River Resort, LLC is granted.
- 2. A prehearing conference is hereby scheduled for this case on February 4, 2008, at 10:00 a.m. The early prehearing conference shall be held in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. The Governor Office Building meets accessibility standards required by the Americans with Disabilities Act.
