On December 22, 2017, Jefferson County Public Sewer District and Utility Management of Missouri, LLC filed a Motion to File Addendum to Joint Application with the Missouri Public Service Commission (“Commission”), requesting that the Commission accept certain verifying affidavits to its application. More than ten days have elapsed, and no party has objected to the request.¹ Staff filed a statement stating that it does not object to the late filing of the affidavits. The Commission finds the request reasonable and will grant it.


THE COMMISSION ORDERS THAT:
