ORDER REGARDING MOTION TO COMPEL

On October 25, 2000, the Staff of the Commission filed a motion to have the Commission compel Ozark Telephone Company (Ozark) to answer certain data requests¹ (DRs). Staff stated that it has complied with the Commission's rules regarding discovery disputes, and has been unable to reach a resolution of the dispute. Staff stated that Ozark committed to answering many of these DRs in 40 days, rather than the default 20 days specified in the Commission's rules. Staff stated that Ozark objected to DR numbers 22, 34, 35, 36, 39, 42, and 48 on the grounds that these DRs seek information for years prior to 1999.

Ozark's objection to these DRs on the ground that they seek information from periods earlier than 1999 is not well founded. In order to determine whether test year expenses are normal, some examination of historical data is needed. The DRs to which Ozark objects are not overbroad, burdensome or irrelevant, and Ozark will be ordered to answer them.

A 40-day period to answer DRs is simply too long in light of the 150-day period in which this case must be decided. Ozark will be ordered

to answer all the disputed DRs immediately, and to comply with the 20-day period set out in 4 CSR 240-2.090(2) for all other DRs.

IT IS THEREFORE ORDERED:

- 1. That the motion to compel filed by the Staff of the Commission on October 23, 2000, is granted.
- 2. That Ozark Telephone Company shall answer DR numbers 1 through 50, 3801, and 3802 as soon as possible, but in no event later than November 3, 2000.
- 3. That Ozark Telephone Company shall comply with the 20-day period set out in 4 CSR 240-2.090(2) for all other data requests.
 - 4. That this order shall become effective on November 3, 2000.
