Notice of Partial ETC Relinquishment

Dear Secretary Woodruff,

By this letter and pursuant to 47 U.S.C. § 214(e)(4) and 20 CSR 4240-31.015(4), USCOC of Greater Missouri, LLC (the "Company" or "U.S. Cellular"), notifies the Commission of the partial relinquishment of its Eligible Telecommunications Carrier ("ETC") designation. U.S. Cellular requests that the Commission issue an order approving the requested relinquishment effective January 14, 2021, 60 days from the date of this letter.

#### Introduction

U.S. Cellular was designated as an ETC by the PSC in 2007 to receive high-cost and Lifeline support from the federal Universal Service Fund. That designation has permitted U.S. Cellular to upgrade and expand its wireless network coverage in rural und underserved areas, and to provide discounted service to qualifying low-income Missourians. In 2013, the Commission approved partial relinquishment of U.S. Cellular's ETC status in connection with the sale of a portion of its network in eastern Missouri.<sup>1</sup>

In 2019, U.S. Cellular undertook to sell another portion of its Missouri network. The transaction, which closed on November 13, 2019, involved the assignment of U.S. Cellular's PCS license covering the St. Joseph BTA in the northwestern corner of the state. Beginning in early August 2019, U.S. Cellular provided notice via letter and SMS text message on multiple occasions regarding the impending termination of service. U.S. Cellular also used multiple outreach methods to provide information to affected customers, including those receiving Lifeline discounts, regarding available wireless alternatives.

Because the completed transaction has reduced the area in which U.S. Cellular can provide service, U.S. Cellular now provides notice that it is relinquishing its ETC designation in those portions of its service area.<sup>2</sup> A list of the rural incumbent local exchange carrier ("ILEC") wire centers to be relinquished is attached hereto as Appendix A; the wire centers making up the remaining ETC service area are listed in Appendix B.

#### Discussion

Pursuant to Section 214(e)(4) of the Act, the Commission "shall permit an eligible telecommunications carrier to relinquish its designation as [an ETC] in any area served by more than one eligible telecommunications carrier." Section 214(e)(4) further provides that prior to approving a relinquishment, a state commission must "require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier."

In the case of a partial relinquishment, it is also necessary to ensure that the remaining ETC areas do not include portions of rural ILEC service areas requiring redefinition pursuant to the federal-state concurrence process set forth in the Federal Communications Act.

U.S. Cellular's relinquishment satisfies all applicable requirements. First, each of the areas to be relinquished pursuant to this Notice is currently served by at least one Commission-designated ETC. Besides U.S. Cellular, all of the areas in Appendix A are served by an ILEC that has ETC status. As ETCs and telecommunications carriers, these companies are required to provide service upon reasonable request throughout these areas. In addition, multiple providers of resold wireless service have been designated as ETCs throughout Missouri for purposes of providing discounted telephone service to qualifying low-income consumers.<sup>3</sup>

Moreover, as discussed above, U.S. Cellular provided ample notice that it was winding down service and identified other service providers for affected customers, including Lifeline customers. Accordingly, there is no doubt that the areas in question are served by more than one ETC and that U.S. Cellular ensured customers will continue to have available service options.

Second, the removal of the areas in question does not require rural ILEC service areas to be redefined. An ETC may be designated in a portion of a non-rural ILEC's study area; however, it may only be designated in a portion of a rural ILEC's study area if the state commission and the FCC agree to redefine the ILEC's service area as something smaller than its entire study area. In connection with U.S. Cellular's original ETC designation, the Commission and the FCC concurred in the redefinition of rural ILEC areas along wire-center boundaries to allow the designation to take effect in rural ILEC areas only partially within U.S. Cellular's licensed area. While this relinquishment will result in the removal of certain rural ILEC wire centers, those ILEC service areas are already redefined as individual wire centers. Accordingly, further redefinition is not needed.

#### Conclusion

For the foregoing reasons, U.S. Cellular respectfully requests that the Commission issue an order approving the partial relinquishment of its ETC designation in the areas listed in Appendix A, effective January 14, 2021.
