## AMENDED ORDER GRANTING ADDITIONAL TIME AND DIRECTING FILING

The Missouri Public Service Commission is granting Total Call Mobile, Inc.'s ("Total Call") *Motion for Additional Time to Respond* ("motion") to the *Staff Report and Response to Total Call Mobile's Answer*.

Staff filed the initial pleading<sup>1</sup> on April 14. Total Call filed its response.<sup>2</sup> Staff filed a reply.<sup>3</sup> The motion<sup>4</sup> asks for additional time to file a sur-reply. Because the reply was four months in the investigation and drafting, the motion is not unreasonable. Therefore, the Commission will grant additional time to file. In addition, the Commission will direct the filing of a joint proposed procedural schedule.

Staff also filed a *Staff Response to Commission Order*. <sup>5</sup> That filing explains that Staff's prayer for provisional relief is most because of a Federal Communications
