ORDER DIRECTING NOTICE, SETTING DEADLINE FOR INTERVENTION AND DIRECTING STAFF TO FILE A RECOMMENDATION

On August 10, 2015, Peaceful Valley Service Company ("Peaceful Valley") filed an *Application for Authority to Reorganize and Motion for Expedited Approval*. Peaceful Valley seeks authority from the Commission to reorganize and convert to a nonprofit water and sewer company and to cancel its Commission-issued Certificate of Convenience and Necessity. If Peaceful Valley's application is approved, the company will no longer be under the Commission's jurisdiction.¹

The Commission will direct notice of Peaceful Valley's application be given to the Gasconade County Commission, local newspapers, members of the General Assembly representing residents of Gasconade County, and the General Counsel for the Missouri Department of Natural Resources. The Commission will also set a deadline for interested parties to intervene or file comments addressing whether or not the proposed

transfer is in the public interest. Finally, the Commission will direct its Staff to file a recommendation on Peaceful Valley's application.

THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall provide a copy of this order and Peaceful Valley's application to the County Commission of Gasconade County, Missouri and the General Counsel for the Missouri Department of Natural Resources.
- 2. The Commission's Public Information Officer shall make notice of this order available to the members of the General Assembly representing Gasconade County, Missouri and to the media serving Gasconade County, Missouri.
- 3. The Commission's Staff shall file a recommendation on Peaceful Valley's application no later than September 8, 2015.
- 4. Any person wishing to intervene in this matter shall file an application to intervene no later than August 28, 2015. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the application can also be made in EFIS.
 - 5. This order shall be effective when issued.
