ANSWER TO COMPLAINT

COMES NOW the Respondent, House Springs Sewer Company, 4089 Country Club Drive, Imperial, Missouri, a public utility, and files this Response and Answer to the Complaint of Complainants filed in this matter.

1. For answer to the Complaint, the Respondent states as follows: pursuant to the tariff issued to House Springs Sewer Company by the Missouri Public Service Commission as more specifically provided on Page 3A thereof, providing in part that a full service restaurant C.I.A.C. rate is \$85.00 per seat. Plans received by Respondent from the customer showed a full service restaurant with 128 inside seats. The 128 seats at \$85.00 per seat equals \$10,880.00, which is the amount listed in the agreement for sewer service. In the event the restaurant installs a garbage grinder, House Springs Sewer Company's tariff lists an additional charge of \$3,000.00, making the C.I.A.C. fee totaling \$13,880.00 plus a \$35.00 inspection fee.


2. In response to Paragraph 4 of the Complaint, Respondent advises the Commission that during its annual inspection in June of this year, the matter with respect to this new restaurant was discussed and reviewed with Mr. Steve Loethen who thereafter discussed the matter with Mr. Jim Busch.

3. It is Respondent's belief, therefore, that in all respects, it is in compliance with the tariff issued by the Missouri Public Service Commission with respect to the nature of this business and establishment.

WHEREFORE, Respondent requests that the Complaint be dismissed.
