ORDER GRANTING INTERVENTION TO VPG PARTNERS VI, LLC

Issue Date: February 9, 2010

On December 4, 2009, VPG Partners VI, LLC, filed an application to intervene. In its application, VPG states that it owns and operates a resort comprised of 135 residential dwellings in the relevant service area and that it conveyed 1.8 acres for the construction of the sewer system.

In order to participate in this case, VPG must either have an interest that is different from that of the general public and would be affected by a final order of the Commission, or by granting VPG's request, the public interest would be served.¹

VPG's interest is different from that of the general public in that it owns a resort in the Respondents service area. Further, parties' have 10 days to file responsive pleadings²

and because no party has done so, VPG's application is unopposed. The Commission will therefore grant the application to intervene.


