**SOUTHWESTERN BELL TELEPHONE COMPANY'S
RESPONSE TO MID-MISSOURI GROUP'S MOTION TO COMPEL**

Southwestern Bell Telephone Company respectfully submits that there is no longer any need for Commission action on the Mid-Missouri Group's (MMG) September 15, 1999 Motion to Compel Responses from Southwestern Bell Telephone Company.

In reviewing MMG's Motion to Compel, Southwestern Bell noted that the MMG had narrowed its request for information from what it had originally been demanding. This change prompted further discussion among counsel which led to a resolution of this discovery dispute.
