



Dear Mayor \_\_\_\_\_:

As you are no doubt aware, St. Louis County Water Company now operates in St. Louis County using the name of Missouri-American Water Company ("MAWC"). Accordingly, the references in this letter to MAWC relate to the Company previously known as St. Louis County Water Company.

The provision of water service to any area requires permission from the State of Missouri through the issuance of a Certificate of Convenience and Necessity by the Missouri Public Service Commission ("PSC"). This authority is unrelated to municipal franchise law, which can also require municipal approval in addition to the PSC Certification. MAWC has provided service within St. Louis County under a perpetual franchise from the County Court of St. Louis County issued in 1902 which predated the creation of the PSC in Missouri. Consequently, a formal certificate has never been sought or issued. All of this is explained in detail in the enclosed copy of MAWC's Application for Restatement and Clarification of Certificate of Convenience and Necessity ("Application").

On October 31, 2000, MAWC filed the enclosed Application, primarily to permit it to contract with the City of Valley Park Missouri to acquire the City's municipally owned water distribution system and thereafter provide retail water service within that City. The Staff of the Commission and the Company agreed that clarification of the 1902 "grandfather" authority within the County should be addressed at the same time to

eliminate any uncertainties associated with the nature and extent of the Company's State authority. Following that Application filing, the PSC directed the Company to provide a copy of it to each municipality within the County. A copy of that directive is also enclosed, because it contains further explanation concerning your ability to participate in the Application proceedings, should you so desire.

Note that the Application specifically states that it does not affect the existence of or necessity for municipal franchises in any manner whatsoever. Paragraph 4.1(C) on page 9 states, "The unusual number of local governments in St. Louis County, coupled with the unprecedented perpetual franchise grandfather rights, by pragmatic necessity leaves the issue of requisite municipal authorities to Applicant's individual relation with each respective municipality." Finally, the prayer of the Application on page 11 requests that, "...the Commission issue its order stating that Applicant has a Certificate of Convenience and Necessity to provide retail water service to... all areas of St. Louis County, Missouri where Applicant is otherwise legally permitted to provide service consistent with its legal relationship with each respective incorporated municipality...."
