Its certificate of authority to transact business in Missouri is on-file with the Commission in the record of Case No. CO-2007-0228 and is hereby incorporated by reference pursuant to Commission Rule 4 240-2.060(1)(G). Sage has no pending action or unsatisfied final judgment or decision against it from any state or federal agency or court which involves Missouri retail customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Notice. No Missouri annual reports or assessment fees are overdue.
- 4. Section 392.461, RSMo, as enacted in HB 338 in 2011, provides as follows:

A telecommunications company may, upon written notice to the commission, elect to be exempt from certain retail rules relating to:

- (1) The provision of telecommunications service to retail customers and established by the commission which include provisions already mandated by the Federal Communications Commission, including but not limited to federal rules regarding customer proprietary network information, verification of orders for changing telecommunications service providers (slamming), submission or inclusion of charges on customer bills (cramming); or
- (2) The installation, provisioning, or termination of retail service.
- 5. Missouri Public Service Commission Staff opened this Case File TE-2012-0073<sup>1</sup> to allow telecommunications companies to file a Notice of Election of Waivers pursuant to Sections 392.245.5(8), 392.420 and 392.461, RSMo.
