ORDER CANCELING CERTIFICATES

On January 14, 2005, the Staff of the Commission requested that the Commission cancel the certificate of service authority of DR Communications, Inc., Lemax, Inc., and Phoenix Telecom, L.L.C. The Commission granted DR a certificate of service authority to provide private pay telephone services in Case No. TA-95-18. The Commission granted Lemax a similar certificate in Case No. TA-98-256, and also granted Phoenix Telecom a similar certificate in Case No. TA-2000-597.

Staff stated that those parties are no longer entitled to have a certificates because they failed to keep the Commission informed of their current addresses, and because they failed to file 2005 Statements of Revenue. On January 18, the Commission ordered those companies to respond to Staff's pleading no later than January 28. They failed to respond.

Section 392.410, RSMo 2000, gives the Commission authority over the granting of certificates of service authority to provide telecommunications services. The Commission has reviewed Staff's pleading, and finds that it should cancel the above-referenced private pay telephone certificates of service authority.

IT IS THEREFORE ORDERED:

1. That the private pay telephone certificate of service authority granted to DR Communications, Inc., in Case No. TA-95-18 is canceled.
2. That the private pay telephone certificate of service authority granted to Lemax, Inc., in Case No. TA-98-256 is canceled.
3. That the private pay telephone certificate of service authority granted to Phoenix Telecom in Case No. TA-2000-597 is canceled.
4. That this order shall become effective on February 11, 2005.
5. That this case may be closed on February 12, 2005.
