- SUBJECT: Staff Recommendation For **Approval** Of Tariff Sheets Filed To Comply With The Commission's June 1, 2011 Order Approving Global Agreement.
- DATE: June 6, 2011

On June 3, 2011, The Empire District Electric Company (EDE) filed with the Commission thirty-eight (38) rates tariff sheets and thirty-nine (39) rules and regulations tariff sheets with an issue date of June 3, 2011, and a proposed effective date of June 15, 2011.

These tariff sheets are designed to comply with Ordered Paragraphs 4 and 5 of the Commission's June 1, 2011 Order Approving Global Agreement (Order). Ordered Paragraphs 1, 4 and 5 of the Order state:

1. The non-unanimous Global Agreement filed on May 27, 2011 is approved. The signatory parties shall comply with the terms of the Global Agreement. A copy of the Agreement shall be attached to this order as "Attachment A."

* * * *

4. Empire shall file new tariff sheets consistent with this order and the specimen tariff sheets attached to the Global Agreement no later than June 3, 2011, bearing an effective date of June 15, 2011.

5. The Commission's Staff may either join Empire with filing its compliance tariff sheets, or file a separate recommendation regarding their approval no later than June 6, 2011.

Revenue Requirement and Rate Design

The revenue requirement increase for EDE is \$18,685,000 or 4.7%. Rate Design tariff sheets filed by EDE comply with the terms of the Global Agreement.

Staff Recommendation

The Staff Commission's Energy Department Staff (Staff) has reviewed the filed tariff sheets, and is of the opinion that they are in compliance with the Commission's Order. Staff therefore recommends that the Commission issue an order approving the following proposed tariff sheets, as filed on June 3, 2011, to become effective on June 15, 2011 as requested by EDE and in compliance with the Commission's Order pursuant to Section 393.140(11) RSMo 2000:
