$\frac{\text{MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE}}{\text{AUTHORITY}}$

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificates of Service Authority to Provide Private Pay Telephone Service, respectfully states:

1. The above captioned individuals (Providers) have been granted certificates of service authority by the Missouri Public Service Commission (Commission) to provide private pay telephone services, pursuant to the Commission's authority under Section 386.250, RSMo 2000.

A list containing information for each of the Providers is marked "Appendix A," attached hereto and made a part hereof.

- 2. None of the Providers listed has returned the Commission's Statement of Revenue form for the FY-2006 Assessment. The Commission has assessed all of the Providers with an estimated assessment of \$0.00.
- 3. Staff believes that the Providers have violated the terms of their certificates of service authority by their failure to file a 2006 statement of revenue.
- 4. Staff attempted to contact each of the Providers on the list. Staff spoke directly to Larry Crow d/b/a L & L Telecom, Mark L. Conlee, and Mojtaba M. Hadjiha and all three specifically requested that their payphone certificates be cancelled. Staff left messages at five (5) of the Provider's last known telephone numbers. One of those five Providers, Larry Fiscus, returned Staff's call and confirmed that he is no longer in the payphone business and has no objections to having his certificate cancelled. The remaining ten (10) Providers' phone numbers have been disconnected or re-assigned.
- 5. None of the providers is delinquent in paying any assessment that may have been assessed during the history of their registration with the Commission. As a payphone provider, the individuals are not required to submit annual reports to the Commission. See 4 CSR 240-3.505(1)(B).
- 6. Staff has made an investigation and no other matters are pending in front of the Commission.
- 7. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5 RSMo 2000, which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. <u>State ex rel. Rex Deffenderfer Enterprises</u>, <u>Inc. v. Public Service Commission</u>, 776 S.W.2d 494 (Mo. App. 1989).

8. Staff is serving this verified pleading (see Appendix B) on the last known address of the Providers as reflected in Appendix A. Commission Rule 4 CSR 240-2.080(17)(C)(1) provides that service by mail is complete upon mailing.

WHEREFORE, the Staff recommends the Commission cancel the certificates of service authority to provide private pay telephone service.
