ORDER CANCELING PRIVATE PAY TELEPHONE CERTIFICATES

Issue Date: January 27, 2006

Effective Date: February 6, 2006

This order cancels the private pay telephone certificates of Randall D. Veselka; Randolph Bradford Clay; Rev. A.A. Boyd; Robert Magaster; Robert Whelan; Rodney S. Holst; Shane Otis Roberts; Shawn Shelton; John A. Havens, d/b/a Southern Missouri Telecom; Steve T. Callis; T. Alvin Robinson; Tamela Privitera, d/b/a T.P. Services; Tony M. Pace; Webb Langworthy, d/b/a Webb Communications; Webb Langworthy; and Craig Wharry, d/b/a Y.A.P. Communications (hereinafter collectively referred to as "Providers").

On December 16, 2005, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificates to provide pay telephone service of the Providers be canceled. Staff alleges none of the Providers has returned a statement of revenue for the fiscal year 2006 assessment. Staff argues that by failing to return the statement of revenue the Providers have violated their certificates to provide payphone services.

Staff stated that it attempted to contact each of the Providers. Staff received information, either by telephone or in writing, that four of the Providers, Tony Pace, Shawn Shelton, Rodney Holst, and Rev. A.A. Boyd, were no longer providing service and wished to have their authority canceled. Staff also left messages at three of the other last known telephone numbers. The remaining nine Providers' phone numbers were disconnected or reassigned.

Staff served its motion on the last known address of the Providers. No responses to Staff's motion were filed.

Section 392.410, RSMo 2000, gives the Commission authority over the granting of certificates of service authority to provide telecommunications services. The Commission has reviewed the motion and finds that the private payphone certificates granted to each of the Providers shall be canceled.

IT IS THEREFORE ORDERED:

1. That the private payphone certificate granted to Randall D. Veselka, in Case No. TA-99-570, is canceled.
2. That the private payphone certificate granted to Randolph Bradford Clay, in Case No. TA-97-177, is canceled.

3. That the private payphone certificate granted to Rev. A.A. Boyd, in Case No. TA-2001-266, is canceled.
4. That the private payphone certificate granted to Robert Magaster, in Case No. TA-99-285, is canceled.
5. That the private payphone certificate granted to Robert Whelan, in Case No. TA-94-289, is canceled.
6. That the private payphone certificate granted to Rodney S. Holst, in Case No. TA-96-437, is canceled.
7. That the private payphone certificate granted to Shane Otis Roberts, in Case No. TA-98-225, is canceled.
8. That the private payphone certificate granted to Shawn Shelton, in Case No. PA-2003-0553, is canceled.
9. That the private payphone certificate granted to John A. Havens, d/b/a Southern Missouri Telecom, in Case No. TA-99-397, is canceled.
10. That the private payphone certificate granted to Steve T. Callis, in Case No. TA-98-75, is canceled.
11. That the private payphone certificate granted to T. Alvin Robinson, in Case No. TA-96-140, is canceled.
12. That the private payphone certificate granted to Tamela Privitera, d/b/a T.P. Services, in Case No. TA-95-427, is canceled.
13. That the private payphone certificate granted to Tony M. Pace, in Case No. TA-98-309, is canceled.

14. That the private payphone certificate granted to Webb Langworthy, d/b/a Webb Communications, in Case No. TA-98-536, is canceled.

15. That the private payphone certificate granted to Webb Langworthy, in Case No. TA-2000-805, is canceled.

16. That the private payphone certificate granted to Craig Wharry, d/b/a Y.A.P. Communications, in Case No. TA-97-432, is canceled.

17. That this order shall become effective on February 6, 2006.

18. That this case may be closed on February 7, 2006.
