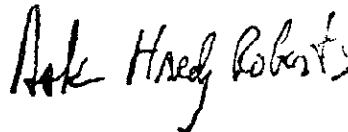

ORDER DIRECTING FILING

On March 22, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion opening a case to consider the necessity and adoption of a rule to change the fees for modular unit inspections. On April 11, 2000, the Staff filed its Motion for Finding of Necessity for Rulemaking with a memorandum attached in support of its motion. Upon review of the Staff's motion, the Commission granted the motion in its order issued on May 2, 2000.

There has been no formal filing or case activity since June 1, 2000. The Commission may dismiss inactive cases pursuant to 4 CSR 240-2.116. Staff shall advise the Commission of its plan and intentions to proceed with this rulemaking by filing a status report stating the next departmental or rulemaking step to completed and the anticipated date of completion.

IT IS THEREFORE ORDERED:

1. That Commission's staff shall file a status report regarding this case no later than January 9, 2001.

2. That this order shall become effective on December 29, 2000.
