ORDER APPROVING TARIFF PURSUANT TO
COMMISSION ORDER AND CLOSING CASE

On May 6, 1999, the Commission issued a Report and Order which directed Mid-Missouri Telephone Company (MMTC) to file tariff sheets designed to implement the rate changes set out in the Stipulation and Agreement. MMTC originally filed tariff sheets on May 14, 1999, with an effective date of May 18, 1999. MMTC withdrew that tariff filing on May 21, 1999, and submitted a new tariff filing (Tariff File No. 9900897) with an effective date of June 20, 1999. MMTC also requested expedited approval of the tariff.

The Commission's Staff reviewed the tariff sheets in light of the Commission's Report and Order and the Stipulation and Agreement. Staff filed a memorandum on May 26, 1999, recommending that the Commission approve the proposed tariff sheets to go into effect as soon as possible. Staff states that the Stipulation and Agreement calls for the elimination of touch-tone charges, reductions in access rates and removal of the intraLATA Carrier Common Line (CCL) Cap, and that the tariff filing accomplishes these requirements.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the revised tariff sheets conform to the

Commission's Report and Order of May 6, 1999, and should be approved to become effective on June 15, 1999.

IT IS THEREFORE ORDERED:

1. That the revised tariff, Tariff File No. 9900897, filed by Mid-Missouri Telephone Company on May 21, 1999, is approved to become effective on June 15, 1999. The tariff approved is:
