ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Starpower Communications, LLC (Starpower) applied to the Public Service Commission on October 5, 1998, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under § 392.440, RSMo 1994¹. Starpower asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by sections 392.361 and 392.420. Applicant is a Delaware limited liability company, with its principal office located at 1130 Connecticut Avenue, N.W., Suite 400, Washington, D.C. 20037.

The Commission issued a Notice of Applications and Opportunity to Intervene on October 13, directing parties wishing to intervene to file their requests by October 28. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party

has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

Starpower filed a proposed tariff in conjunction with its application and filed substitute sheets on November 3, November 6 and November 10. The tariff's effective date was extended to November 27 at the request of counsel for Starpower in a letter filed on November 6. Starpower's tariff describes the rates, rules, and regulations it intends to use, identifies Starpower as a competitive company, and lists the waivers requested. Starpower intends to provide interexchange telecommunications services including 1+, 800/888/877, Directory Assistance, Private Line and Travel Card services.

In its Memorandum filed on November 17, the Staff of the Commission stated that Applicant's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant Applicant a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on November 27.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and Applicant should be granted a certificate of service authority. The

Commission finds that the services Applicant proposes to offer are competitive and Applicant should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Starpower's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange carriers. The Commission finds that the proposed tariff filed on October 5 shall be approved as amended to become effective on November 27.

IT IS THEREFORE ORDERED:

- 1. That Starpower Communications, LLC is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That Starpower Communications, LLC is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
