**ORDER SETTING BRIEFING SCHEDULE AND DIRECTING THE FILING  
OF PROPOSED FINDINGS OF FACT AND CONCLUSIONS OF LAW**

On August 15, 2006,<sup>1</sup> Central Jefferson County Utilities, Inc. (“Central Jefferson”) filed two identically captioned applications seeking authorization to transfer and assign certain assets of its water and sewer operations to the Jefferson County Public Sewer District (“Sewer District”). To facilitate the proceedings, the Commission consolidated these cases, designating Case No. SO-2007-0071 as the lead case. The Commission held an evidentiary hearing in this matter on December 19 and 20.

Pursuant to Commission Rule 4 CSR 240-2.140(2), the Commission will allow the parties to file post-hearing briefs. The Commission will also direct the filing of proposed findings of fact and conclusions of law.

**IT IS ORDERED THAT:**

1. Any party who wishes to file a post-hearing brief shall do so no later than January 23, 2007.

2. Any party who wishes to respond to a post-hearing brief shall do so no later than February 2, 2007.

3. All briefs and amendments shall be filed in accordance with Commission Rule 4 CSR 240-2.080. Briefs shall follow the same list of issues as filed in the case and must set forth and cite the proper portions of the record concerning the remaining unresolved issues that are to be decided by the Commission.

4. Each party shall prepare and file proposed findings of fact and conclusions of law, including citations to testimony and other evidence, no later than January 23, 2007.

5. All parties shall provide an electronic copy of their briefs and proposed findings of fact and conclusions of law, in Microsoft Word format, to the regulatory law judge at [harold.stearley@psc.mo.gov](mailto:harold.stearley@psc.mo.gov).

6. This order shall become effective on December 22, 2006.
