ORDER APPROVING ADOPTION NOTICE IN COMPLIANCE WITH COMMISSION ORDER

On July 10, 1998, the Commission issued an Order Approving Transfer of Assets authorizing the transfer of assets from CBS Corporation, d/b/a Westinghouse Communications (CBS) to RSL COM U.S.A., Inc. (RSL). The order required that RSL make necessary tariff filings to add CBS's services. The order also provided that on October 13, 1998, CBS's certificate of authority to provide interexchange telecommunications service and its accompanying tariff will be canceled. On September 16 RSL filed an adoption notice to comply with the Commission's order by adopting CBS's tariff. On October 7 RSL filed a substitute sheet. The adoption notice bears an effective date of October 17.

On October 7 the Staff of the Commission (Staff) filed a memorandum which indicated that the adoption notice filed by RSL is in compliance with the Commission's order. Staff recommended that the Commission issue an order approving the adoption notice effective October 17. Staff also recommended that the certificate of authority to provide interexchange telecommunications service and the accompanying

tariff of CBS not be canceled until October 17, rather than October 13 as originally ordered.

The Commission has reviewed the adoption notice filed by RSL and the Staff's memorandum. The Commission finds that the adoption notice filed by RSL on September 16, as substituted on October 7, is in compliance with the Commission's order. The Commission also finds that the certificate of authority to provide interexchange telecommunications service and the accompanying tariff of CBS should not be canceled until October 17.

IT IS THEREFORE ORDERED:

- 1. That the adoption notice filed by RSL COM U.S.A., Inc. on September 16, as substituted on October 7, 1998, adopting the tariff of CBS Corporation, d/b/a Westinghouse Communications, is approved and shall become effective on October 17, 1998.
- 2. That Ordered Paragraph 6 of the Order Approving Transfer of Assets issued on July 10, 1998, shall be amended to state that Westinghouse Corporation, d/b/a CBS Communications's certificate of service authority to provide interexchange telecommunications service shall be canceled on October 17, 1998.

- 3. That this order shall become effective on October 17, 1998.
- 4. That this case may close on October 18, 1998.
