ORDER APPROVING TARIFF SHEETS
FILED IN COMPLIANCE WITH REPORT AND ORDER

On August 6, 1997, the Commission issued a Report And Order in this docket which directed Missouri Gas Energy, a division of Southern Union Company (MGE), to file compliance tariff sheets no later than August 8.

On August 8 MGE filed tariff sheets in compliance with the Commission's Report And Order. On August 11 MGE filed five substitute tariff sheets to correct certain typographical errors.

On August 12 the Staff of the Missouri Public Service Commission (Staff) filed a memorandum to the official case file. Staff notes that the purpose of the language changes contained in the substitute tariff sheets filed on August 11 is to more clearly reflect the provisions of the Stipulation And Agreement referenced in the Commission's order and does not substantially alter the form or meaning of the tariff sheets presented to the Commission on July 14. Staff recommends that the tariff sheets filed by MGE on August 8 as amended by the substitute sheets filed on August 11 be approved for service rendered on and after August 15, 1997.

The Commission has reviewed the proposed tariff sheets and Staff's recommendation. The Commission finds that the proposed tariff sheets

comply with the Commission's Report And Order and underlying Stipulation And Agreement.

IT IS THEREFORE ORDERED:

1. That the following tariff sheet be approved for service rendered on and after August 15, 1997, interim subject to refund pending final Commission decisions in Case No. GR-97-78 and Case No. GR-96-450.
