**APPLICATION FOR AUTHORITY TO SELL, ASSIGN
OR TRANSFER ASSETS AND MOTION FOR EXPEDITED APPROVAL**

Comes now Time Warner Cable Information Services (Missouri), LLC ("TWCIS"), d/b/a Time Warner Cable, by its undersigned counsel, and hereby applies pursuant to Sections 392.300, R.S.Mo. 2002, and 4 C.S.R. 240-2.060 and 4 C.S.R. 240-3.520 for authority to sell, assign or transfer assets. Pursuant to 4 C.S.R. 240-2.080(16), TWCIS also seeks expedited approval of this Application. In support of its Application, TWCIS states:

1. Applicant TWCIS is a limited liability company duly organized and existing under and by virtue of the laws of the State of Delaware. TWCIS is wholly-owned by Kansas City Cable Partners ("KCCP") and Time Warner Entertainment Company, L.P. The information required pursuant to 4 C.S.R. 240-2.060(1)(B)-(F) was submitted in Case No. LA-2004-0133 and is incorporated herein by reference. On March 2, 2004, TWCIS was granted authority to provide basic local, local and interexchange service in portions of the State of Missouri and was classified as a competitive company.

2. All inquiries, correspondence, communications, pleadings, notices, orders and decisions relating to the case should be addressed to the counsel listed as attorneys of TWCIS for this Application. In addition, TWCIS provides the following information:

3. As part of a corporate restructuring being effected by the entities that own KCCP, a new wholly-owned subsidiary of KCCP, to be known as "KCCP Trust," will be formed. It is contemplated that all assets of KCCP, including its entire ownership interest in TWCIS, will be transferred to KCCP Trust. KCCP Trust (as is the situation currently with KCCP) will not be subject to the jurisdiction of this Commission because TWCIS will continue to hold and eventually operate the certificate of service authority granted in Case No. LA-2004-0133.

4. TWCIS seeks expedited approval of this Application in order to avoid the risks and uncertainties failure to received such consent would have upon the pending restructuring transaction involving the entities that comprise KCCP. The restructuring transaction must close no later than April 30, 2004. Failure to meet that deadline might cause the transaction to terminate.

5. TWCIS recently became aware of the potential adverse effect that failure to obtain the subject regulatory approval prior to April 30, 2004 could have on the KCCP entities. There will be no negative effect on customers or the general public if the Commission acts by the date requested. Further, this Application was filed as soon as possible under the circumstances.

6. TWCIS does not currently serve any customers in Missouri so there will be no impact on any customer nor the tax revenues of any political subdivision.


7. TWCIS has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the Application. No Missouri annual reports or assessment fees are overdue.

WHEREFORE, applicant Time Warner Cable Information Services (Missouri), LLC respectfully requests that the Commission grant it authority to sell, assign or transfer its assets to KCCP Trust on an expedited basis.
