**SOUTHERN MISSOURI NATURAL GAS'  
MOTION FOR CLARIFICATION AND RECONSIDERATION**

**COMES NOW** Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas ("SMNG"), and for its Motion For Clarification And Reconsideration of the Report and Order issued on February 5, 2008, in this matter respectfully states as follows:

1. On page 14 of the Report And Order, the Commission stated:

And, since SMNG has yet to obtain a municipal franchise to serve Branson West, the CCN to serve Branson, Hollister, and Branson West cannot become "final" until SMNG is granted the missing franchise.

2. SMNG believes that this sentence should be clarified to read as follows:

And, since SMNG has yet to obtain a municipal franchise to serve Branson West, the CCN to serve Branson West cannot become "final" until SMNG is granted the missing franchise.

3. SMNG is seeking to obtain a franchise for Branson West. However, SMNG does not believe it is reasonable to delay its expansion of its service territory into Branson and Hollister which have already granted or assigned municipal franchises to SMNG, while the Company is seeking to obtain a municipal franchise in Branson West.

Therefore, the sentence referenced above should be reconsidered and clarified so

that the certificate to serve Branson and Hollister may become "final" after the conditions contained in the Report and Order are satisfied, even if a municipal franchise for Branson West has not been granted to SMNG.

WHEREFORE, Southern Missouri Gas Company, L.P. d/b/a Southern Missouri Natural Gas requests that the Commission reconsider and clarify its Report And Order as described herein.
