1. Applicant is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principa! office and place of business located at Route 4, Box 30, Osage Beach, Missouri 65065. It is a public utility proposing to render water service to the public under the jurisdiction of the Commission. A copy of its Certificate of Incorporation and Articles of Incorporation may be found in Case No. WM-89-73 previously filed with the Commission.

3. Applicant requests permission, approval, and a certificate of public convenience and necessity to install, own, acquire, construct, operate, control, manage and maintain a water system for the public in an area including part of the City of Osage Beach, Missouri, all of the Village of Sunrise Beach, Missouri plus unincorporated portions of Camden and Miller Counties, Missouri, as set forth on the map attached to this application as Exhibit 1, and legally described by metes and bounds in Exhibit 2 attached to this application.

 The feasibility study is attached to this application and made a part hereof as Exhibit 3.

5. There are no municipalities located within the proposed area other than the City of Osage Beach, Missouri and the Village of Sunrise Beach, Missouri. Applicant has obtained approval from the City of Osage Beach, Missouri to provide water service as a public utility in the part of the proposed service area under its jurisdiction; a copy of Resolution No. 8912 of the Board of Aldermen of the City of Osage Beach, Missouri to that effect is attached hereto as Exhibit 4. Applicant has obtained approval from the Village of Sunrise Beach, Missouri, to provide water service as a public utility in the part of the proposed service area under its jurisdiction; an affidavit of William P. Mitchell with duplicate original of the resolution of the Board of Trustees of the Village of Sunrise Beach Missouri, to that effect is attached hereto as Exhibit 5. Aside from the City of Osage Beach, Missouri, the Village of Sunrise Beach, Missouri and the Public Service Commission, no other entities have jurisdiction over water service by a public utility within the proposed service area.

6. Said water system meets all requirements of the Commission and the Department of Natural Resources.

7. There are no other public utilities or governmental bodies being operated or rendering water service within the area proposed to be served.

8. The area requested is rapidly being developed into subdivisions by developers and plans are being made to build residential homes and other establishments within the area, all of which will need adequate water and sewer service. Therefore, a public need exists for adequate water service within the area proposed to be served and the public convenience and necessity will be promoted by the granting of the authority herein requested.



Economic Feasibility Study for Osage Water Company

The Company acquired the water utility serving approximately 75 customers, including and surrounding the Harbor Town development, in 1989. The owners are primarily in the construction, operation, and laboratory business of commercial water and wastewater systems in central Missouri. We have reached an agreement with two subdivision developers to form a partnership to provide expertise in legal and heavy construction, and increase the size of the company. This reorganization will provide stability and economies of scale necessary to provide high quality service at the Lake of the Ozarks. The areas to be added are a subdivision contiguous to the existing service area plus an area adjacent, all in Camden County.

The existing systems to be added have been constructed by the developers, and any expansion will be by the main extension rules.

Currently the combined systems service 60 apartments, 3 duplexes, 15 homes, 8 trailers, and a Pizza Hut. The water use varies seasonally and is not all metered.

The service areas to be added are primarily residential but include some commercial land. We expect to add one home per month at an average flow of 3,000 gallons per month over the next 5 years.

The rates and fees for water service are to remain the same as existing, \$7.75 minimum which includes the first 1,000 gallons, then \$2.07 per 1,000 gallons thereafter. The appropriate existing schedules are attached as exhibits A (rates) and B (fees).

The rates and fees for sewer are proposed to be a minimum of \$15.34 which includes the first 2,000 gallons and \$4.83 per 1,000 gallons thereafter and attached as exhibit C. Fees for sewer service are to be the same as for water service (Exhibit B).


Current income is averaging \$500 per month as shown in the 1990 schedule of income and expenses attached as exhibit D.

See exhibit 3 of the Co-filed Application for the Recapitalization of the Company for a detailed income and expense for the next 3 years.

Financing is not required at this time. The areas to be added provide a positive cash flow for necessary cash expenses. The principals will provide the operation, maintenance, laboratory, legal, and construction services to the Company in exchange for company indebtedness if required. This will provide a safety net for the Company, and maximize stability and growth.

William Mitchell holds an "A" license in both water and wastewater operation in the state of Missouri and is currently completing a MSCE degree at MU. Greg Williams is an Attorney with a practice in Sunrise Beach, Missouri and with prior experience with utilities. Dave Hancock owns and operates a bonded heavy construction company in Sunrise Beach, Missouri.
