COMES NOW the Staff of the Missouri Public Service Commission (Staff) and in Response to Kansas City Power & Light's (KCPL) Response to Staff's report concerning Staff's Evaluation of KCPL's System Performance and Employee Safety and Training Programs (Staff Evaluation) states:

- In its February 1, 2001 Order, the Missouri Public Service Commission (Commission)
 ordered KCPL to respond to Staff's Evaluation and the Staff, in turn to respond to KCPL's
 Response.
- On March 28, 2001, KCPL responded to Staff's Evaluation, indicating that it concurs with Staff's overall findings concerning KCPL's system performance and safety and training programs.
