STAFF'S REPORT OF REVISED PROJECTED EXHAUST DATE FOR 314 NPA

COMES NOW the Staff of the Missouri Public Service Commission and for its report states:

1. The Technical Implementation Subcommittee filed its Report on August 31, 2001, which, *inter alia*, noted its disagreement with the projected exhaust date of the second quarter of 2002 for the 314 Number Plan Area (NPA).

2. The Staff, the Office of the Public Counsel, Southwestern Bell Telephone, and Verizon Wireless were in support of NeuStar, as the North American Numbering Plan Administrator, revising the projected exhaust date for the 314 NPA because recent code assignments had not been at levels previously projected.

3. On September 19, 2001, NeuStar revised the projected exhaust date to the first quarter of 2004 for the 314 NPA.

4. As of August 2001, there were 150 codes available for assignment in the 314 NPA.

5. Based on the revised projections from NeuStar, it is quite possible that the 314 NPA will not be included in the initial phases of the national roll-out.
