APPLICATION FOR APPROVAL OF INTERCONNECTION AGREEMENT

COMES NOW Applicant Dobson Cellular Systems, Inc. ("Dobson" or "Applicant"), by and through counsel and pursuant to Section 252(e) of the Telecommunications Act of 1996 ("the Federal Act") and the applicable provisions of 4 CSR 240-2.060, and for its Application for approval of its Interconnection Agreement with ALLTEL Communications Services Corporation ("ALLTEL") respectfully states as follows:

I. 4 CSR 240-2.060 Requirements

- 1. Applicant's legal name is Dobson Cellular Systems, Inc. Applicant's principal office is located at 13439 N. Broadway Ext., Suite 200, Oklahoma City, Oklahoma 73114-2257, telephone number (330) 509-6525, fax number (330) 565-9562.

- 3. Dobson is an Oklahoma corporation duly authorized, either directly or through its affiliates, to do business in Missouri. Dobson is engaged in the business of providing commercial mobile radio services as licensed by the Federal Communications Commission.

 Pursuant to 4 CSR 240-2.060(1)(C), Dobson's relevant documents from the Missouri Secretary of State's Office are attached hereto and incorporated herein by reference as Appendix A.
- 4. Pursuant to the relevant provisions of Section 386.020 RSMo Supp. 1999, Dobson is not a "public utility" and therefore is not subject to the general regulatory jurisdiction of this Commission. However, this Commission does have jurisdiction over both the subject Interconnection Agreement pursuant to the Federal Act, and over the co-signatory to the Interconnection Agreement, incumbent basic local exchange carrier ALLTEL, pursuant to the relevant provisions of Chapters 386 and 392 RSMo.
- 5. Pursuant to 4 CSR 240-2.060(K) and (L), Dobson affirmatively states that: (i) it has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application; and (ii) no annual report or assessment fees are overdue.
 - 6. As this not a joint application, any information relating to ALLTEL is not here

being submitted. However, Dobson notes that this Commission has already and recently approved similar commercial mobile radio services interconnection agreements between ALLTEL and other wireless carriers¹ and to the extent this additional information is required for purposes of this Application, the information provided by ALLTEL in those prior cases may be deemed to be incorporated herein by reference pursuant to 4 CSR 240-2.060(G), if necessary. Consistent with the Commission's past practice, Dobson anticipates that the Commission automatically will make ALLTEL a party to this proceeding when the Commission issues its standard notice in this case.

II. The Interconnection Agreement

- 7. Dobson presents to this Commission for its approval the Commercial Mobile Radio Services Interconnection Agreement, with attachments ("the Agreement"), negotiated and executed by and between Dobson and ALLTEL on January 3, 2001 pursuant to the terms of the Federal Act. An executed original of the Agreement with attachments, with the pages numbered sequentially in the bottom right hand corner, is attached hereto as Appendix B to this Application.
- 8. Dobson seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act. Dobson believes that the implementation of the Agreement complies fully with Section 252(e) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and because it does not discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, promotes

interconnectivity, and increases customer choices for telecommunications in Missouri. As such, approval of the Agreement also is consistent with the policies of Chapter 392 RSMo.

- 9. The Agreement is in all substantive respects similar to other ALLTEL Commercial Mobile Radio Services Interconnection Agreements which have been previously approved or which are currently under review by this Commission.² There are no outstanding issues between the parties which require arbitration by this Commission. In order to avoid additional post-approval filings, Dobson already has sequentially numbered the pages of the Agreement in the right hand corner of each page consistent with the Commission's past practice. As such, Dobson requests prompt approval of the Agreement without change, suspension or other delay in its implementation.
- 10. The appropriate standards of review of the Agreement by this Commission are found in Section 252(e) of the Federal Act and are well known to the Commission. Dobson respectfully submits that under these standards, this Commission should not reject and should approve the Agreement, consistent with the Commission's past treatment in prior cases involving similar ALLTEL-negotiated commercial mobile radio services interconnection agreements.

WHEREFORE, Applicant Dobson Cellular Systems, Inc. respectfully requests that the Commission expeditiously approve the Interconnection Agreement between Applicant and ALLTEL Communications Services Corporation.


